Common/Shared values as a distinction to imports


**Constant threat of referendums**

Support for local farmers against risks from globalisation


High-input production - response to the war in Ukraine






## Bilateral agreements CH and the EU: important for the food-sector

- Participation in the EU internal market tariffs to protect Swiss agriculture are nevertheless comprehensive
- Independence of Swiss agricultural policy
- Export of cheese and processed products
- AOP, IGP and organic production: mutual recognition
- Food safety and animal health
- Cost reduction for farmers, processors and trade
- Royal choice of products for consumers












#### Not a step down!
